## **Basic Conditions and Procedures for Purchase**

## **Alignment Rolling Resistance Reference Tire (ARRRT)**

ARRRT is a test tire intended to be used only for alignment of a rolling resistance testing machine in accordance with ISO 28580.

This is to advise you of basic conditions and procedures for the purchase of ARRRT from us.

If you wish to purchase ARRRT from us, please read this document carefully and take the procedures set forth below.

## 1. Basic Conditions

## (1) Prices and other costs:

The selling price for each unit of ARRRT is as follows:

The selling price for each unit of PC-F and PC-H includes the cost of rolling resistance measurement test, data of which will be sent to you by post or international courier service at the time of shipment of the ARRRT.

The ARRRT will be air-shipped by international courier service on a COD basis to you at your shipping address set forth in the Request for Quotation. The courier service will be chosen by us and the cost of transportation will be borne by you on a COD basis.

Export fees to be advised to you in the Quotation for Your Request shall also be borne by you.

## (2) Unit to be ordered:

Please order a set or sets of PC-F and PC-H. ISO 28580 requires you to use a set of two different alignment tires for the alignment procedure.

#### (3) Limited Use:

ARRRT is a test tire intended to be used only for alignment of a rolling resistance testing machine in accordance with ISO 28580. Do not use and do not allow any third party to use ARRRT for any other purpose. Especially, do not use and do not allow any third party to use ARRRT on vehicles.

For caution to users, the words "TEST PURPOSE ONLY" and "NOT FOR HIGHWAY SERVICE" are imprinted on the sidewall of ARRRT.

#### (4) Shipment:

The ARRRT will be shipped to you on a FOB basis.

#### (5) More Detailed Terms and Conditions and Individual Contract:

More detailed terms and conditions that shall apply to the individual contract for sale and purchase of the ARRRT between you and us will be advised to you with the Quotation for Your Request.

Individual Contract for sale and purchase of the ARRRT between you and us shall be deemed to have been executed when we have received your completed order form and the total amount set forth in our Quotation for Your Request, in accordance with the procedures set forth below.

## (1) Request for Quotation:

#### (2) Quotation:

After we receive a completed Request for Quotation from you, we will review it. Unless it is against our internal policies or rules including without limitation our export compliance, we will send you by email a "Quotation for Your Request" which includes:

- (i) Prices
- (ii) Scheduled date of shipping; and
- (iii) Our bank account information

#### (3) Order:

When you receive the Quotation for Your Request from us, please review it carefully. If the Quotation for Your Request is acceptable to you, please (i) fill in and sign the order form at the bottom of the Quotation for Your Request, (ii) send it by e-mail to us at ARRRT Sales and (iii) remit to our bank account the total amount set forth in the Quotation for Your Request. Do not detach the order form from the Quotation for Your Request when you send them by e-mail.

Please also note that in any case the payment shall be made in advance in Japanese yen by bank remittance to our bank account and that the remittance charges shall be borne by you.

## (4) Shipment Date:

The Scheduled Date of Shipment set forth in the Quotation for Your Request is Seller's best effort basis and is not fixed. The actual date of shipment shall be subject to change due to the schedule of the Rolling Resistance Measurement test or any other reasons. If Seller estimates that the actual date of shipment is ahead of or behind the scheduled date of shipment by more than 10 days, Seller shall advise Buyer thereof.

Upon shipment, we will also send by post or international courier service the Rolling Resistance Measurement test data to you at your shipping address set forth in the Request for Quotation. Please check whether the serial number of the ARRRT such as "PC-F0001" is the same with that shown in the test data.
